Directions from Knoxville exit 398(scenic):

Going east exit 398 Strawberry Plains Parkway ;

Take a left under the freeway and continue on Strawberry Plains Parkway for 3 miles. Turn right, at the Sunoco. There will be a light there.;

Travel on 25/70 5.2 miles taking a left at Douglas Dam Rd.

There will be a BP station on the corner; Travel 1 mile taking a left at the T which is a continuation of Douglas Dam Rd (or Snyder/Route 66); Travel .2 miles and take a right onto Piney Rd ; Travel 1.3 miles and take a left on Eslinger (will come up on you suddenly check odometer on this one); .2 miles a left on Blue Springs .

.6 miles is Roderick Ln on the left. Travel till the dead end, slightly curve with the stone mailbox to the gate. Follow signs to the Lodge.
